### ADMISSION

Admission at Australian Manufacturing Week (AMW) is free to trade personal.

It is a condition of entry that all trade visitors are registered. Students or children under the age of 14 will not be admitted unless accompanied by an adult.

The Organiser (AMTIL) reserves the right, with reasonable cause, to refuse entry or remove any person, including any person who causes a disturbance, or refuses to comply with reasonable requests made by the Organiser.

### ANIMALS

No animals are permitted within the Melbourne Convention & Exhibition Centre (MCEC) precinct or grounds at any time except licenced assistance animals, for which such copy licence is required to be produced upon request and as certified by law.

### CANVASSING

Canvassing for business by any unauthorised persons is strictly prohibited. The display and distribution of printed or other materials (except by exhibitors within their own stands) is prohibited.

### CHILDREN

For trade visitors with children, please visit AMW Registration between Entrance Doors 7 and 8 to sign a disclaimer form and acquire a pass for your child(ren) before entering the exhibition.

Groups of students will not be admitted except by prior arrangement with the organisers.

### CUSTOMER SERVICE

AMW Customer Service is located between Concourse Doors 7 and 8 of the Exhibition Centre.

### HEALTH & SAFETY

The health and safety of AMW visitors and exhibitors is of paramount importance.

By attending AMW, you agree to follow all current health & safety protocols as communicated by AMTIL and MCEC staff, official contractors and relevant Government Departments.

Except for in the event of negligence on the part of the Organiser, AMTIL will not be liable for any injury, loss or damage suffered by you in connection with the event and the venue, including liability for any injury, loss or damage caused by the Organiser or its employees, contractors or agents.
