### ADMISSION

Admission at Australian Manufacturing Week (AMW) is free to trade personnel. It is a condition of entry that all trade visitors are registered. All registrations will undergo a review and verification process, and all visitors will need to show valid photo identification (ID) at AMW to gain access to the exhibition. Your registration badge and photo ID must be carried with you at all times whilst at the event.

Students or minors under the age of 15 will not be admitted unless accompanied by an adult. Minors attending AMW must be accompanied by a guardian at all times in and around the venue. Guardians are required to sign a waiver upon arrival at AMW Registration.

The Organiser (AMTIL) reserves the right, with reasonable cause, to refuse entry or remove any person, including any person who causes a disturbance or does not comply with AMTIL's Event Code of Conduct, or refuses to comply with reasonable requests made by the Organiser.
